Concept

The Government of Uzbekistan has demonstrated commitment to integrating children with special needs into mainstream institutions. This Project is responding to a need for the provision of additional support to the Government's legal, financial and technical frameworks regarding the development of an Inclusive Education system.

Objective

To improve the quality of education for children with special needs between the ages 2–10 and promote their integration into mainstream kindergartens and primary schools in Uzbekistan.

Contribution to social inclusion in Uzbekistan

Components

- 1 Development of a robust and sustainable long-term strategy for inclusion of children with special needs, including government legal and financial frameworks and instruments for data collection.
- 2 Development and piloting of pre-service and in-service teacher training modules and non-teacher staff training modules on inclusive education.
- 3 Ensuring visibility for Inclusive Education, Disability and Child Rights issues at the national and local level – to enhance community awareness, to sustain political commitment, to secure sustainability of developments regarding inclusion in society and education, and to provide basis for better lives for disabled people.

- At least 840 children with special needs aged 2–10 are included in mainstream kindergartens, preschools, schools.
- At least 670 teachers and 170 support staff are trained and operational.
- At least 1350 children and parents receive consultation and support.

Inclusive Education in Uzbekistan

The inclusion of children with special needs in mainstream education makes them an increasingly normal part of the child population. Children, parents, professionals and the citizenship at large come to understand that difference is normal and that those who are different are not inferior or threatening. This leads to the development of a more inclusive society in general.

The National Center for the Social Adaptation of Children (NCSAC) - a key stakeholder organisation for this Project was founded in 2004 to provide information, counselling and legal support to children with special needs from vulnerable and underprivileged groups and their families, as well as comprehensive medical and educational assistance to disabled children. Since 2004, the Center has provided support and assistance for their integration into society to over 11 000 children from vulnerable groups and their families, including over 5000 disabled children who have received support and treatment at the Center's Information and Consulting Service (ICS).

The major partner ministries for this Project, the Ministry of Public Education and the Ministry of Higher and Secondary Special Education, plus the Ministry of Labor and Social Security and the Ministry of Public Health are committed to working with other stakeholders to develop an Inclusive Education system in Uzbekistan.

Major programmatic documents in Uzbekistan relevant for Inclusive Education are the Resolution for Introduction of Inclusive Education for Disabled Children (2010) and the Education Sector Plan for 2013–2017.

From key relevant legal documents, Article 45 of the Constitution of the Republic of Uzbekistan states that "The rights of minors [and] the disabled [...] shall be protected by the state," and Article 65 - that "Children shall be equal before law." The Law On Guarantees of the Rights of the Child (Jan 2008) provides the legal basis for the rights of all children with disabilities. The most recent changes in legal provisions and policy related to children with disabilities are included in the Law On Social Protection of People with Disabilities in Uzbekistan (last amended Oct 2013).

From international treaties, Uzbekistan has ratified the UN Convention on the Rights of the Child. It is also undertaking substantial steps toward the ratification of the UN Convention on the Rights of Persons with Disabilities.
